Susan Holstedt currently lives in Kansas City, MO with her husband, Craig, who is a retired P.C.(U.S.A.) pastor. As an Enrolled Agent, she is authorized to represent taxpayers before the IRS. She has been preparing individual tax returns for almost 40 years and often consults with sessions and presbyteries to develop compensation guidelines and maximize pastors' packages, particularly in small churches. Susan is the owner of S&H Tax Service and prepares around 200 tax returns a year, of which about 40% are clergy. She serves as finance faculty for the CREDO program offered by Board of Pensions and has presented BOP webinars on tax updates and college planning.
