In Iola, we were quite fortunate that leadership decided to begin a live-stream broadcast of worship services several years ago. This meant that Sunday mornings were relatively unchanged as I decided for the sake of continuity and



familiarity to continue with a regular order of worship. We have modified a few things but still broadcast each Sunday morn, save for a few glitches electronically and one Elijah's-got-nothing-on-us storm!

Pastorally I have had to do what all pastors have done, relying on phone, email, and text messaging much more. I have also tried to make happenstance meetings around town with members and friends of FPC, Iola more than a simple hello – I have tried to ask about the well-being (physically, mentally, and spiritually) of them and family. It is with a great and deeply felt sigh of relief that all of us here in Iola have been healthy COVID-19 wise and I have kept the undertaker at bay as well.

Then, just as it seemed that the COVID-19 storm was beginning to lessen we had to brace ourselves with even less preparation time for the next storm to hit our nation and society. Iola's Black Lives Matter rally was planned by a group of locals who invited me in on it, and on Sunday afternoon, June 9, 250 people came to the square while many others watched online or have viewed the video of our very successful and peaceful rally.

Though denied regular worshiping practices we have found our church to live and well and prospering! Though denied our presence together we have found our voices in service still. Though denied freedom as we had grown accustom to we have relished and, perhaps, come to understand our freedom in Christ Jesus to be even sweeter.

Bill and Brenda Havens have been in the ministry over 40 years. They have faithfully served congregations in Texas and the greater Springfield, Missouri area including Southminster Presbyterian Church, Ash Grove United Methodist/Presbyterian Church, and Westminster Presbyterian Church. Bill has provided dedicated leadership and pastoral support among John Calvin Presbytery.

Earlier this year, Brenda was diagnosed with a life-threatening heart condition requiring a specialized procedure not available in Springfield. On June 23rd a cardiac surgeon performed the complex surgery at the K.U. Medical Center, Overland Park, Kansas.

While in recovery Brenda sustained a major heart attack. She has experienced

further complications and the medical team anticipates Brenda will be hospitalized at KUMC for several weeks. It is likely she will require further surgery.

Bill stays in a hotel during the week so he can be near Brenda. He returns to Springfield on weekends so he can tend to the needs of their son Eric. As you might expect, hotel, travel, and medical expenses are mounting daily.

Box 787 Shell Knob, Missouri 65747 **PULPIT SUPPLY** for a minister leading worship and preaching for a congregation as a visiting minister should ordinarily receive \$100.00, plus the IRS approved mileage amount per vouchered mile (2020 IRS rate \$0.575 per mile). Pulpit Supply is \$100.00 with the understanding that is only if one (1) service is to be prepared. It was approved by COM that if two (2) services are required the honorarium would be \$150.00. If overnight lodging is required, motel and meals should be provided at the church's expense. Honorarium for moderating a session is \$50 plus the IRS approved mileage rate per vouchered mile.
