**Wednesday, May 27, 2020**

We have received word that the Reverend Dr. Thomas H. Cavicchia has died **Wednesday, May 27**.

Tom was ordained by Newark Presbytery on **June 15, 1954**. He served as pastor of First Presbyterian Church, Mt. Vernon, Missouri from 1962 to 1971 and then as Executive Presbyter, for JCP, from 1971 until his retirement in 1994. Moved by affection and gratitude, John Calvin Presbytery elected Tom as Executive Emeritus on **October 29, 1994**.

**PULPIT SUPPLY** for a minister leading worship and preaching for a congregation as a visiting minister should ordinarily receive \$100.00, plus the IRS approved mileage amount per vouchered mile (2020 IRS rate \$0.575 per mile). Pulpit Supply is \$100.00 with the understanding that is only if one (1) service is to be prepared. It was approved by COM that if two (2) services are required the honorarium would be \$150.00. If overnight lodging is required, motel and meals should be provided at the church's expense. Honorarium for moderating a session is \$50 plus the IRS approved mileage rate per vouchered mile.
