FAIR TRADE STORE at PRESBYTERY MEETING!

In 2005, members of John Calvin Presbytery attended the Peacemaking Conference at Ghost Ranch, New Mexico. Six members of Bethany Church in

Joplin were among the group. As we rode home, we discussed the workshops and gatherings, and the six of us felt that our church wasn't as deeply involved in mission as God was calling us to be. When we returned home, we made our report to Presbytery. We decided to ask our Session and Presbytery for help to open a Fair Trade Store. As a small church, our resources were limited, and Presbytery gave us a grant to begin.

We purchase Fair Trade goods from several sources including SERRV and Ten Thousand Villages. We pay wholesale price and pass that savings on. Bethany does not take any profit but returns the proceeds back into new purchases. Sales help people in many countries around the world to improve their way of life by providing education and medical opportunities and by giving women financial security and freedom to choose the way they live.

Our stock comprises Holiday items, some jewelry, household goods and gift items. **Bring your checkbook or cash and be part of mission....we will be at the Presbytery Meeting on November 5 at Trinity Presbyterian Church!**
