


# Opportunity to Receive Coaching & Cohort Training

Missouri Union Presbytery, in partnership with the Omaha Presbyterian Seminary Foundation (OPSF), and two other presbyteries, applied for and received a one million dollar grant from the Lily Foundation. The program is called "Pastoral Leadership Revitalization."

All pastors in the Synod of Mid America who are new to rural ministry in the last five years are invited to participate. There are a total of 15 openings and they will be filled on a first come, first serve basis. All costs of program participation are covered by the grant.

An invitation to participate and the application are attached. Please let Malinda Spencer know if you are considering applying, and if you have any questions. The deadline for submission of applications is June 30.

The Pastoral Leadership Revitalization program is designed to increase pastoral resilience and stem the attrition rate of ordained and lay pastors. The Omaha Presbyterian Seminary Foundation is aware that pastors in isolated communities, whether rural or urban communities, and first call pastors, are especially susceptible to feeling isolated, and therefore, is eager to support and encourage such pastors in their ministry. A vital way to support pastors is through a coaching mentor,

ney as a pastor. We are inviting pastors with great potential to partner with a coaching mentor, that they may be even more successful in their ministry. You are one such pastor.

#### What will you receive by participating in this program?

You will be part of a cohort of pastors and commission ruling elders, engaged in revitalizing ministry in their congregations.

You will be energized for ministry by attending the retreats for pastors and CREs.

Your family will be supported by attending the retreats for families.

Your congregation will benefit from the ways in which you are growing from working with a mentor and attending retreats.

The coaching you receive is valued at \$1,000/year. The retreats would cost about \$500/retreat. You will receive these benefits at no cost to you.

#### What will be expected of you?

Attend retreats offered by your presbytery. The first retreat will be September 15-18, 2019. There will be two retreats per year in 2020 and 2021.

Meet with your coaching mentor at least once a month, either face-to-face, by phone, or virtually (such as through Zoom).

Be willing to be coachable and teachable.

Be open to participating in spiritual direction.

- Provides a \$5,000 grant to borrower to be used to pay down their student loan
- Can reapply up to 4 times for a total of \$25,000 of assistance
- Eligibility:
- be a Presbyterian Church (U.S.A.) minister enrolled in Pastor's Participation in the Benefits Plan;
- have completed a CREDO conference or the Healthy Pastors, Healthy Congregations program;
- have an effective salary below \$80,000 and a total household adjusted gross income\*\*
  of less than twice the national median for pastors (currently \$118,200) as reported on the most recent income tax return;
- meet criteria established by the Board to ensure the need-based nature of the program; meet a student loan debt coaching requirement; and
- repay your documented, interest-bearing educational debt by a specified monthly amount based on your effective salary a nd the amount of debt (see Grant recipient educational debt repayment commitment chart).

- Provides a forgivable loan for \$5,000
- Loan is paid directly to borrower's loan servicer
- After 1 year of service loan is forgiven
- Borrower can reapply up to 4 times for a total of \$25,000 of assistance over 5 years
- Eligibility:

Minister of the Word and Sacrament Serving in a part-time, temporary or designated roll in a worshiping community Must have student loan debt

**PULPIT SUPPLY** for a minister leading worship and preaching for a congregation as a visiting minister should ordinarily receive \$100.00, plus the IRS approved mileage amount per vouchered mile (2019 IRS rate \$0.58 per mile). Pulpit Supply is \$100.00 with the understanding that is only if one (1) service is to be prepared. It was approved by COM that if two (2) services are required the honorarium would be \$150.00.

If overnight lodging is required, motel and meals should be provided at the church's expense. Honorarium for moderating a session is \$50 plus the IRS approved mileage rate per vouchered mile.
