#### **Report of Committee on Ministry**

Elder Reina Daleske, Moderator of the Committee on Ministry, moved the following:

1. That Presbytery approve minimum terms of call for 2024 based on increased cost of living and inflation: Minimum full-time salary is \$47,380.00 and with the Board of Pensions rate of 39% the total effective salary is \$65,858.20. All terms of call in 2024 must include paid Family Medical Leave in compliance with the Book of Order G-2.0804. Motion approved.

2. That Presbytery reaffirm the current stipulations that: • All salary minimums apply equally to Teaching Elders and Commissioned Ruling Elders. • Part-time salary minimums should be calculated as a percentage of the full-time salary minimum. For example (based on the full-time minimum of \$47,380.00 for 2024): 1/4 time = \$11,845.00 1/3 time = \$15,635.40 1/2 time = \$23,690.00 3/4 time = \$35,535.00 • The minimum Continuing Education allowance is \$1,500.00 for both

full-time and part-time calls of each church and each person • Pulpit supply minimums are: \$125.00 plus mileage at the current IRS rate for one service and \$160.00 plus mileage at the current IRS rate for two services (on same day) • \$60.00 plus mileage at the current IRS rate for moderating a Session or Congregational meeting. Motion approved.

3. ## **Report of Administrative Ministries Committee**

Moderator, the Rev. Bob Dahlgren brought the report of Administrative Ministries. In addition to the filing of the financial records on the Consent Agenda, Bob brought the following motions.

That John Calvin Presbytery continues the agreement begun in 2020 whereby the Presbytery provides a grant of \$11,500 to First Presbyterian Church, Webb City, Missouri to pay for pastor's participation in medical dues in the Board of Pensions for the Reverend Charles Spencer, which will cover the Spencer family with a savings to John Calvin Presbytery of about \$16,000 for the year 2024. Motion approved.

That the Terms of Call for 2024 and 4% salary increase for the Executive Presbyter, Ruling Elder Malinda Spencer, be approved. Motion carried.

That the Terms of Call for 2024 and 4% salary increase for the Stated Clerk, Rev. Becky Schwandt, be approved. Motion carried.

Bob then provided a list of the actions taken by AMC for information:

## Actions taken:

- 1. AMC recommended to General Council that Per Capita be set at \$40.25 with the following breakdown: General Assembly-\$9.80; Synod of Mid-America-\$3.15; JCP-\$27.30.
- 2. AMC recommended to General Council that Greg Emery's status be changed from an employee of John Calvin Presbytery (Transitional Pastor) to a consultant. \$12,000 will remain in the budget. This would allow JCP churches in need of Greg's services to continue working with him with these churches paying one half of Greg's fees and John Calvin Presbytery matching, in keeping with the budget. The Committee on Ministry would be consulted to make these arrangements.
- 3. AMC recommended to General Council that the proposed 2024 John Calvin Presbytery Budget be approved.
- 4. AMC approved a 4% increase in salary for John Calvin Presbytery staff.
- 5. Reviewed and approved minutes of meetings and email votes through September 22, 2023.
- 6. AMC is in the process of completing JCP staff annual evaluations.
- 7. AMC is revising the Presbytery Expense Voucher Form.
- 8. AMC is working on a Recycling and Ecology policy to make available to JCP as a model for congregations to consider as they take steps toward care for God's good creation.
- 9. The AMC is currently looking for a person(s) to serve as a Recording Clerk to take minutes during Presbytery meetings.
- 10. John Calvin Presbytery has received a \$50,000 donation to be used toward Rural Pastoral Leadership Scholarships. Details will be available at a later date

11. The KPM annual independent Accountant Review of last year has been received. The committee and staff (Treasurer and Executive Presbyter) will be reviewing the report.

### **Treasurer's Report**

Treasurer Dennis Winzenried spoke about the importance of Shared Mission and Per Capita. Dennis found that if each church gave \$120 per member (Per Capita and Shared Mission money combined) we'd not have to draw from our reserves. He thanked the churches who had given their Per Capita and Shared Mission pledges to the presbytery and hope those who haven't yet sent theirs in will do so before the end of the year.

Dennis then shared the following report:

On the Balance Sheet you'll see that we have \$187,983.61 in our Great Southern Account. Great amount to have in the bank. Of this \$85,000 is committed. \$35,000 is pass-through the presbytery because of the closing of the Mulberry church. These checks have been written and money sent.

Then on a very positive note we received a \$50,000 gift for the establishment of funds for Rural Pastoral Leadership. This will be added to money we have set aside for the Lay Academy and help rural churches in the days to come. Others could do something similar to help our churches. We give thanks for this gift given. I say all that to say that in reality we have just over \$100,000 in our checking account.

On the Budget vs Actual report, you'll see that we have received \$45,617.60 vs. the annual budget of \$90,000. That is a little over 50% of the budget in 75% of the year. I'm hoping churches will give shared mission year end gifts.

The Rev. Daniel Davis asked if the council needed any other instruction and made a **motion to have 3 presbytery members gather and research ideas between now and February 24, 2024 for hybrid presbytery meetings.** Seconded by Toni Spieth. Moderator Kira Anderson opened the floor for discussion. A discussion ensued about the necessity of the sub-committee. Kira then called for a vote. **Motion failed.** 

Jim Holt moved that the following amount be approved as the Per Capita apportionment for 2024: (Please note the only change for 2024 is in the Synod of Mid-America which increased by \$0.25. This is the first change from the Synod in many years.)

## Motion approved.

The Rev. Daniel Davis, moderator-elect, stepped in as Moderator for the next motion. The conversation being held is regarding the sale of Shoal Kirk which is owned by First Presbyterian Joplin where the Rev. Kira Anderson is the co-pastor.

Jim Holt then invited COM Moderator Reina Daleske to present the three motions for Administrative Commissions.

## Reina presented the following:

That pursuant to our presbytery policy Steps for the Sale of Property, General Council makes a motion that John Calvin Presbytery appoint an Administrative Commission to work with First Presbyterian Church in Joplin, MO. This Administrative Commission shall be delegated the power of John Calvin Presbytery to determine whether or not to give written permission to sell, mortgage or otherwise encumber its property pursuant to G-4.0206a to the session of the congregation after careful consideration of the congregation's decision to sell, mortgage or otherwise encumber its property and the intended mission of the proceeds. Furthermore, we move that the following people be named to this Commission: The Rev. Chris Miller, Elder Dick Pogue, and Elder Mert Barrows. Dan opened the floor for discussion. Kira spoke about the process the congregation has gone through to come to the decision to sell Shoal Kirk Campground. Motion approved.

Kira then told the body that they would like to auction the property. There is a reserve price that will be kept secret. The Administrative Commission will know and there are a handful of people at First Joplin that know. It was also noted that JCP has not sold any property by auction in the past.

Bob Dahlgran, Moderator of Administrative Ministries Committee made a motion to allow First Presbyterian of Joplin, Missouri to be able to sell Shoal Kirk, by auction, if the reserved is met. Motion was seconded and the floor opened for discussion. Questions were asked about the process if the property did not meet the reserve.

The Rev. Chris Miller offered the following substitute motion: **To grant permission for** *First Joplin to sell Shoal Kirk, via auction, and pending the approval of the AC on the day of the auction. In the event the property does not sell at auction, Joplin, be given*  *permission to list the property.* Motion seconded. No discussion. Dan Davis called for a vote on the substitute motion. **Motion carried and became the main motion.** 

Dan Davis then called for a vote on the main motion: **To grant permission for First Joplin to** sell Shoal Kirk, via auction, and pending the approval of the AC on the day of the auction. In the event the property does not sell at auction, Joplin, be given permission to list the property. Motion was seconded and approved.

#### Reina Daleske introduced the following:

That pursuant to our presbytery policy Steps for the Sale of Property, General Council makes a motion that John Calvin Presbytery appoint an Administrative Commission to work with Stockton Presbyterian Church in Stockton, MO. This Administrative Commission shall be delegated the power of John Calvin Presbytery to determine whether or not to give written permission to sell, mortgage or otherwise encumber its property pursuant to G-4.0206a to the session of the congregation after careful consideration of the congregation's decision to sell, mortgage or otherwise encumber its property and the intended mission of the proceeds.

This Administrative Commission shall be delegated the power of John Calvin Presbytery to review the ongoing mission and ministry of Stockton Presbyterian Church, consult with its members and elders, assume original jurisdiction if deemed that the session cannot exercise its authority over governance, finances, or the selling of property, and make a recommendation to John Calvin Presbytery as to whether the congregation is continuing in the mission and mission of the presbytery or whether the congregation may need to be dissolved. Furthermore, we move that the following people be named to this Commission: the Rev. Jack Cormack, the Rev. Jane Huffstetler, the Rev.Christine lannucilli, and Elder Bill Martin. Motion carried.

#### Reina then offered the following motion:

In response to a request from the session of Hollister Presbyterian Church, we make a motion that John Calvin Presbytery appoint an Administrative Commission with the Rev. Barry Williams, Elder Deb Field, and Elder Sue Wright to walk alongside Hollister Presbyterian Church in Hollister, MO in selling their property and discerning whether the congregation may need to be dissolved. This Administrative Commission shall be delegated the following powers of John Calvin Presbytery:

A. To determine whether or not to give written permission to sell, mortgage or careful consideration of the congregation's decision to sell, mortgage or otherwise encumber its property and the intended mission of the proceeds

B.To hire appropriate professional help as needed such as legal counsel, appraisers, real estate broker, etc.

C.To make recommendation to the Presbytery on use or disposition of property, real or personal.

D. To assume original jurisdiction over the existing session after thorough investigation and after full opportunity to be heard has been accorded to the session, when it should become evident to the Administrative Commission that the session of Hollister Presbyterian Church is unable or unwilling to exercise its authority or is unable or unwilling to manage wisely its affairs.

E. In consultation with the members and elders of Hollister Presbyterian Church, to determine the date of last worship service, the date of dissolution, and the best way to give thanks to God for the ministry of the congregation;

F. To receive Access to all church records, including but not limited to:

- membership rolls,
- minutes of Session and all boards and committees,
- financial records
- membership directories
- newsletters
- and materials distributed for congregational information. To call a congregational meeting (G-1.0503) and to obtain current and accurate membership lists from the church for this purpose.

G. To provide for worship and for the continuing pastoral care of all members of the congregation, in the manner of Christ;

H.To receive and act on request from members to be transferred to another congregation of the Presbyterian Church (U.S.A.) or deleted from the rolls;

I.To dissolve any pastoral relationship, fully observing the due process requirements of the Constitution, G-2.0901 and G-2.0904, and/or dissolve any temporary pastoral relationship fully observing the due process requirements in presbytery policies;

J.Under Form of Government, Chapter Four, The Church and Civil Authority of the Book of Order, G-4.0203 and G-4.0205 all property of Hollister Presbyterian Church is held in trust for the Presbyterian Church (U.S.A.). The Administrative Commission of John Calvin Presbytery, appointed on this date, is authorized to take possession of all real and personal property, financial records, inventories of equipment, and arrange for transfer of title to the

Presbytery of all accounts and real property known to be in the possession of Hollister Presbyterian Church. Including but not limited to:

- bank accounts,
- stocks,
- trusts,
- real property to consult with the session regarding requests the congregation may have relating to the disposition of equipment and memorials and other property of Hollister Presbyterian Church.

K. To consult with the session regarding requests the congregation may have relating to the disposition of equipment and memorials and other property of Hollister Presbyterian Church.

L.To assert claim of the presbytery to any property of Hollister Presbyterian Church not known at this time or property which may come to Hollister Presbyterian Church as the beneficiary of a will or trust not known at this time.

M.To dissolve the corporation when appropriate. N.To assure continuation of insurance on all properties of the congregation.

O.To share with the presbytery the history of the congregation, giving thanks for the ministry

P. To report back to the presbytery the process and actions taken.

#### Motion approved.

Reina moved that the proposed budget for 2024 for John Calvin Presbytery be approved. Motion carried.

Reina moved that the Rev. 1. Several Grants were approved and will be presented at the November 4th, 2023 John Calvin Presbytery Meeting:

- Ash Grove United Methodists/Presbyterian Church– to receive \$600 to purchase Feminine Hygiene Products to be distributed at the Diaper Pantry that operates from the church.
- First Presbyterian Mt. Vernon to receive \$600 to purchase Feminine Hygiene Products to be distributed at the Community Diaper Pantry that operates from the church.
- Ozark Presbyterian Church- to receive \$175 to cover pulpit supply while pastor was attending 2 meetings related to her work as JCP clerk on October 9-14. (Expense for pulpit supply couldn't come from the pastor's expense account to attend these meeting).

- First Presbyterian Church Nevada- to receive \$800 to provide nursery care for after school volunteer's younger children and purchase of additional games and playground equipment.
- Hillcrest Presbyterian to receive \$800 towards purchase of iPads to enhance the engagement of children and youth in Faith Formation during Christian Education time and during worship.
- Although not requesting any additional money at this time, St. Andrew Presbyterian in Kimberling City has asked that some of the money that was shared with them last year for audio visual updates (not spent yet), be shifted towards an immediate need for replacing siding on the building where squirrels are entering the building. The church will match this dollar for dollar.

2. General Council approved a motion to modify all church grant applications to include a section for all churches requesting funds to indicate if they have given (or are in process of giving quarterly) their Per Capita for the current year. There will also be a place for churches to indicate if they participate in the giving of a voluntary gift to Shared Mission.

3. Treasurer Dennis Winzenried will remind those churches who receive grants that John Calvin Presbytery requests a report of how the grant money was used and an evaluation of the effectiveness of the grant the following year.
